AGREEMENT

(To be executed at the time of admission on non-Judicial stamp paper)

1. This agreement is made between
(hereinafter called the Guarantor, which expression shall unless excluded by the context or the meaning thereof be deemed to include his heirs, executors, administrators and legal representatives) of the one part and the Board of Governors, (hereinafter called the Governors which expression shall unless excluded by the context or the meaning thereof be deemed to be represented by the Headmaster of the Doon School, Dehra Dun) of the other part.
2. Whereas Roll No. son of (hereinafter called the Student) son/ward of the guarantor and has at the request of the guarantor been selected for admission to The Doon School for the purpose of receiving education inter alia, on the terms and conditions hereinafter appearing.
3. Now it is hereby agreed by and between the parties hereto as follow:
 - (a) That in consideration of the student being admitted by the governors to The Doon School for the purpose of the aforesaid education at the request of the guarantor he, the guarantor, convenants with the Governors that the student will attend the Doon School regularly and will observe and comply with all the rules and regulations thereof for the prescribed period, and that he the guarantor shall pay to the Governors regularly and promptly and whenever called upon to do so all the fees and other costs as prescribed.
 - (b) That the said student has been admitted on the understanding that his first term is probationary and that he will be required to leave the School at the end of the first term or first year if the Headmaster is of the opinion that his capability and attainment do not reach the standard specified as requisite for admission.**
 - (c) that the placing of students in different forms will be at the sole discretion of the Headmaster.
 - (d) that the Headmaster can, at any time, in the interest of the School, have the student removed if in the Headmaster's sole discretion the student has failed to accept the discipline of the School and his continued presence is detrimental to the interest of the other students and/ or the student fails to come up to the academic standard of his class and when detention in the same class would make the student to old for his class.
 - (e) that no fees, partial or full, will be refunded if the said student is required to leave the school during term time for any reasons other than medical grounds acceptable to the Headmaster.
 - (f) that the Governors will not be liable for any damages/charges on account of injuries, fatal or otherwise, which may be sustained by the student, at any time during his stay in the School while or outside the School premises. All expenses that may be incurred in the treatment of such injuries will be borne by the parent/guardian as provided in the rules of the Doon School.
 - (g) And that if there is any dispute as to the effect or meaning of these presents or in any way touching or arising out of these presents, the same shall be referred to the sole arbitration of the Board of Governors, The Doon School, Dehra Dun, whose decision shall be final
